TOXICOLOGICAL RISK ASSESSMENT

INTRODUCTION

SGS is requested to review the safety of the product formula LEGEND AGE HEALTHY CHERRY LIPSTICK for consumer health and no other part of the product. The product is for US market and intended for application on lips for keeping it in good condition by babies of 0 year old or above. The net weight of the product (The formulation under assessment) is 3.8 g per consumer product. Detailed formulation is submitted by the client as in Section I. Ingredients are not presented in the report, whereas they are recorded in the SGS Archives.

LITERATURE SOURCES

This review was compiled by using information gathered from raw material suppliers and various online databases including the EU Scientific Committee on Consumer Safety (SCCS) opinions, Cosmetic Ingredients Review (CIR); detailed references are not reported here but are recorded in the SGS Scientific Archives.

Section I: FORMULATION

According to the client's needs and to protect business secrecy, detailed formulations are NOT presented in this report, whereas they are recorded in the SGS Archives. In case of medical events, it is the client's responsibility to provide the formulations to a patient's physician, or SGS upon request may furnish relevant medical units, on a confidential basis, information necessary to diagnose or treat cases of exposure without prior written authorization.

Fragrance

No fragrance components have been indicated to be present in the formulation.

Section II: COMPLIANCE WITH COSMETIC REGULATION

In accordance with US Food, Drug and Cosmetic Act, above-mentioned formulation contains restricted chemicals as below:

- (a) Yellow 5 is permitted for general cosmetics including eye area use, when it conforms to FDA specifications.
- (b) Red 22, Red 6, and Red 28 are permitted for general cosmetics, when it conforms to FDA specifications.

No information about manufacturing is available. It is highly recommended that the product is manufactured according to Good Manufacturing Practice (GMP). The ingredients used shall fulfill corresponding purity requirements. It is also assumed that the ingredients in this product contain no contaminants or residues at level that would be toxic, corrosive or irritating to the skin, eyes or mucous membranes, or cause a sensitization reaction in a consumer who may be exposed. If it is not the case, it will void this assessment. None of the ingredients are prohibited to be used in cosmetic products as indicated in the US Food, Drug and Cosmetic Act (FD&C Act) 21 CFR Part 73, 74, 81, 82, 250.250, 700, and 740. It can be concluded that the formulation as supplied complies with US Food, Drug and Cosmetic Act.

Consumer Exposure Scenario

The following assumptions have been made for assessment of exposure:

Product category: LipstickPhysical form: Semi-solid

Intended use: Application on lips for keeping it in good conditions

Frequency of use: 1460 times per year

• Exposure route(s): Primarily via dermal contact and potential oral ingestion

Product amount: 3.8 g

Amount per application: 0.01 g

Exposure area: 4.8 cm²

Exposure duration: 360 minutes

Body weight: 5 kg

Target population: Babies of 0 year old or above

Risk Characterization for Consumer Health

Local Effects

Irritation: Not expected to cause skin and eye irritation under normal and reasonably foreseeable

conditions of use.

Sensitization: There are substances of allergenic potential but at low level that is not expected to induce

an allergenic reaction in the majority of the users. However, sensitized people can react to

allergen present at extremely low concentrations.

Phototoxicity: Exposure to this product is unlikely to result in phototoxic effects.

Systemic Effects

As there is a chance of ingestion of this lip product with customary use, the ingredients used should be of food grade or any appropriate grade. Provided the manufacturer's instructions are followed, this formulation is unlikely to cause damage to internal organs through skin and ingestion under normal and reasonably foreseeable conditions of use.

Joint Toxic Action

Based on current knowledge, joint toxic action is not anticipated.

Section IV: CONCLUSIONS:

The submitted formulation complies with the US Food, Drug and Cosmetic Act (FD&C Act) 21 CFR Part 73, 74, 81, 82, 250.250, 700, and 740. It is not expected to cause acute or chronic skin and eye irritation, acute or chronic oral, dermal or inhalation toxicity or be a strong sensitizer as defined in 16 CFR 1500.3(c)(4), 1500.3(c)(2), 1500.3(c)(3) and 1500.3(c)(5). The product is highly recommended to be manufactured according to Good Manufacturing Practice (GMP). Provided the manufacturer's instructions are followed and all the ingredients used are of cosmetic grade, it is considered that, in the present state of knowledge, the submitted formulation put on the market is unlikely to pose a significant risk to the health of intended consumer under normal and reasonably foreseeable conditions of use.
